


二、Principles and methods

1、Objective and principle of test

Cosmetic stability refers to a product's ability to maintain its original physical, chemical, and microbial properties, sensory characteristics, and safety standards during the shelf life under intended usage conditions. Stability testing involves evaluating how quality parameters of cosmetic products transform or change under specific environmental conditions. This process helps identify quality variations over time, thereby assessing potential safety risks and ensuring product integrity.

This experiment examines the degree and law of change of cosmetic products over time under specific environmental conditions (such as temperature, relative humidity, etc.), and examines the sensory, physical and chemical and microbial changes of test samples, so as to evaluate the stability of cosmetic products within the specified shelf life and under storage conditions.
